Student/Parent/ Guardian also is aware there is some risk of injury that may result during instruction, including but not limited to as a result of physical contact with other students, instruction, fixed or moveable objects or the condition of the floor. Ballet Arts of Bucks County (BABC) shall not be responsible for injuries, loss or damages suffered by the student, caused or alleged to be caused by the negligence of BABC. Further, I understand and accept that in order to be taught effectively, the student's dance training may involve the use of touch by the faculty members as a necessary tool for correct placement, lines, and positions. The student is expected to maintain acceptable behavior within the classrooms, corridors, and dressing rooms. I understand and accept that all students must adhere to the standards of behavior set forth by the faculty, as well as the written studio guidelines, including the COVID protocols listed below:

New COVID-19 SAFETY PROTOCOLS

- If you DO NOT FEEL WELL and/or HAVE A FEVER or any symptoms, DO NOT ATTEND IN STUDIO CLASSES
 - If your student or someone who lives in your household has been exposed to COVID, DO NOT ATTEND IN STUDIO CLASSES. Please keep our studio as safe as possible.
 - **Please follow PA state mandates for quarantine and mask/face coverings** Please follow any changes in the Pennsylvania State Mandates for mask wearing, and abide by the studio's mask requirements.
 - Students should arrive 5-10 minutes before class. Please do not arrive late. Wait in the hallway until teacher invites you into dressing room/studio
 - Limit your drop off to as few people as possible (one parent and limited siblings). If your child is old enough and you feel comfortable, you can send your student upstairs alone. If requested a student can provide the teacher with a phone number, and staff will text you that your child has made it up to the studio safely. Since young children often need to use the bathroom or need a parent at a moment's notice, parents or guardians of children 5 and under should remain in the hallway/lobby for classes 45 minutes or shorter in length
 - NO ONE except for staff and dancers will be allowed into the Ballet Arts Lobby and Dressing Room. We ask that you limit your waiting in our halls, if possible leaving and coming back to pick up. We will have only a few benches and stools set out in hallways. Please be respectful and social distance when picking up and dropping off.
 - Cell phones must be left in the dance bags. No cell phones allowed for use in the studio.
 - The staff will make every attempt to plan their classes with social distancing/water and mask breaks in mind.
- I hereby waive all claims against BABC and also agree to hold BABC harmless from any and all claims, costs, liabilities, expenses, or judgements, including attorney fees and court costs (herein collectively called "claims") arising out of the student's participation in BABC's programs and productions. For any illness (including but not, limited to COVID-19) or injury resulting therefrom, I hereby further agree to indemnify and hold harmless the BABC staff, faculty, and officers as to any and all claims.
